# **APPOINTMENTS**

Your appointment is a 50 minute session hour that you have reserved. This is time specifically set aside for you. *If you cannot keep the appointment, we request that you notify your counselor of your cancellation 24 hours in advance.* This is to allow more time to offer the session to another person. If an appointment is failed without notification, a charge may be made for that time.

## FINANCIAL INFORMATION

#### Fees

Client fees are to be determined at the first session hour or preferably when the appointment is made. Our normal and customary fee is \$120 per session hour. The initial diagnostic assessment fee is \$175 and may take up to 90 minutes. Sliding fees are available based on income and ability to pay. Please clarify any questions with the office manager or your counselor.

# **Credit Policy**

All clients are encouraged to keep current in the payment of their accounts. Full payment or co-payment/coinsurance is expected at the time of **appointment.** We will not extend credit beyond three sessions unless waiting for insurance reimbursement or special financial arrangements have been discussed and agreed to. The accounts will be billed to the client with payment due within 30 days of billing unless a payment plan is arranged.

## Third Party Payment

Your medical insurance may cover a portion of the fee for services you have Clients agree to pay their received. portion of the fee including any unmet deductible, co-payments, co-insurances, and any fees not paid for by insurance. We do accept most Medical Assistance occasionally though a referral authorization is needed. This office will assist you in making your insurance claim. but cannot accept responsibility for collecting on your claim, verifying your coverage, nor negotiating settlement of your claim. Your insurance has a responsibility to you, not our office. Please advise your counselor at the time of your first visit or when you make the appointment.
